ORDER

Dr. Leeja A Mohan, Assistant Surgeon filed OA 833/2025 before the Hon'ble Kerala Administrative Tribunal with a prayer to direct the first respondent (Secretary, H&FWD) to consider and pass orders on Annexure A8 Appeal in accordance with law. Hon'ble Kerala Administrative Tribunal in its order read as 1st paper above has directed the first respondent to consider and pass orders on Annexure-A8 without any further delay, at any rate, within a period of two weeks from the date of receipt of a copy of the order. It has also ordered that the vacancy that is due to arise at FHC, Kollayil on 01-06-2025 due to retirement shall not be filled up till orders are

passed on the Annexure A8 appeal.

- 2. In the Annexure A8 appeal read as 1 st paper above , the applicant submitted that, in the General Transfer 2025, she has been transferred and posted to Taluk Head Quarters Hospital, Parasala, Thiruvananthapuram denying SC/ST protection and violating the transfer guidelines . The applicant requested to transfer her to any of the opted station or in the next arising at FHC, Kollayil in Thiruvananthapuram .
- 3. The Director of Health Services as per letter read as 3 rd paper above has reported the following.

Dr. Leeja A Mohan, Assistant Surgeon is working at Primary Health Centre, Perumpazhuthoor, Thiruvananthapuram since 29-04-2022. She has joined Health Services Department on 31.07.2009 and worked continuously at Thiruvananthapuram district from 09.06.2010 onwards. The applicant has already availed the SC/ST protection while working at CHC, Perumkadavila from 09/06/2010 to 28/06/2018. She had applied for General Transfer 2025 with the following options.

While considering the online transfer request submitted incumbents eligible get transfer by other to Thiruvananthapuram district, for giving an opportunity to all employees to work in their home district Thiruvananthapuram, some incumbents of Thiruvananthapuram district were posted to hospitals other than their options. In these circumstances, Dr. Leeja A Mohan is posted at Taluk Head quarters Hospital, vacancy FHC, arised at Parassala. One Thiruvananthapuram due to the retirement of Dr. Vijayadas R on 31.05.2025. Dr. Leeja A Mohan is continuously working at Thriuvanathapuram District since 09.06.2010 and presently she is posted at Thiruvananthapuram District itself. Many requests were received from Medical Officers for considering them in vacancies at Thiruvananthapuram District. So incumbents from other Districts are more eligible to get posting at FHC, Kollayil.

4. Government have examined the matter in detail. Dr. Leeja A.Mohan, is working at Primary Health Centre, Perumpazhuthoor, Thiruvananthapuram since 29-04-2022. Dr Leeja A Mohan who joined Health Services Department on 31-07-2009 is working continuously at Thiruvananthapuram from 09-06-2010 onwards and also at present she got posting at Thiruvananthapuram District only. She has already availed

SC/ST protection. The other eligible medical officers are posted at Thiruvananthapuram considering their transfer requests for giving an opportunity to all employees to work in their home district Thiruvananthapuram. In the above circumstances , the Annexure A8 appeal submitted by the applicant is hereby rejected.

5. The order of the Hon'ble Kerala Administrative Tribunal read as 1st paper above is complied with as above.
