Dr.Anitta K Jossi PEN.497849 now Junior Administrative Medical Officer completed her PG Course on 31.08.2022. She submitted request for rejoining duty as per read 2nd above. Since there was no vacancy in the cadre of Assistant Surgeon existed at that time due to the enhancement of retirement age of Doctors from 56 to 60 years as per GO(MS) No.169/2017/ H&FWD Dated 28.11.2017 and anticipatory vacancies reported to PSC, she could not join duty as Assistant Surgeon after completion of PG Course. As per paper read 1st above this office had posted Dr. Anitta K Jossi at Taluk Hospital Pazhayangadi Kannur as Asst. Surgeon. Thereafter as per paper read 3rd above this office has regularized the period waited for posting as duty ie, the period from 01.09.2022 to 21.09.2022.

As per the circular read 6th above Govt.have directed that incumbents should intimate their proposed date of rejoining sufficiently early,ie 2 months at least in advance.It is also directed that ,in the case

of employees who fails to do so the time lag between the day on which the Medical Officer rejoin duty and the day on which the expiry of leave period shall be treated as eligible leave or LWA or non-duty.

Therefore, the period waited for posting cannot be treated as duty in the absence of vacancy in the cadre. As per read 4th above Government have directed to cancel the order in which it is regularised the period from 01.09.2022 to 21.09.2022 as duty.

In the above circumstances the order read 3rd above is hereby cancelled.
