ORDER

Dr.Nisha.J.Haridas, Assistant Surgeon has filed OA(EKM) 971/2025 before the Hon'ble Kerala Administrative Tribunal seeking a direction to consider and pass order on Annxure A8 representation read as 1st paper above.

2. The Hon'ble Kerala Administrative Tribunal as per order read as 2nd paper above directed the 1st respondent to consider and pass orders on Annexure A8 representation read as 2nd paper above within a period of 1 month from the date of receipt of a copy of the order.

3. In the Annexure A8 representation read as 2nd paper above, the applicant submitted the following:

Presently working as Assistant Surgeon in Taluk Hospital, Balussery, Kozhikode. In the draft list of General Transfer 2025, posted at PHC, Panangad, Kozhikode which was one of the options in General Transfer application. But when the final list was published posted at District Hopsital, Vadakara which was not in the submitted options. An appeal was submitted before DHS after the final list. But it was not considered. The present station allotted is 45 kilometre away from residence and it will create difficulties for the education of the children. In the representation it was requested to give posting at one of the preferred options of the applicant.

4. The Director of Health Services as per letter read as 3 rd paper has reported the following:

Dr.Nisha J Haridas, Assistant Surgeon is working at Taluk Hospital, Balussery Kozhikode since 09/09/2021. She joined Health Services Department on 31/07/2012 and worked continuously at Kozhikode district from 31/07/2012 onwards. She had applied for General Transfer 2025 with the following options.

As per the norms in GO (P) No. 03/2017/ P&ARD dated 25.02.2017, the option of Dr. Roshna Raj V Rajan (Assistant Surgeon at Taluk Headquarters Hospital, Koyilandy since 11/08/2018) was considered and she was posted to Taluk Hospital, Balussery, in place of Dr. Nisha J Haridas.

As per the norms of GO (P) No. 03/2017/ P&ARD dated 25.02.2017, the following are the incumbents posted at options of Dr Nisha J Haridas.

1.PHC Panangad, Kozhikode

Sreedevi T. R., Taluk Headquarters Hospital, Feroke Kozhikode having station seniority from 26-04-22. Dr. Nisha J Haridas was initially posted at this option in the draft list of General Transfer 2025 of Assistant Surgeons. As per norms of General Transfer, institutions within 15 km are considered as the present station. The distance between Taluk Hospital Balussery Kozhikode and PHC PANANGAD is only 4.4 Km. After publishing draft list an appeal was received against her posting at present station itself. Therefore, while considering appeals from other eligible incumbents her posting at PHC Panangad was changed.

- b) Dr. Sreeja J. S., CHC Mokkam, Kozhikode having station seniority from 27-04-22.

Dr Sreeja A P Govt Taluk Hospital Balussery having station seniority from 29-02-20

Dr. Chithra Mukundan C. M, Government Rural Dispensary Quarters, Vellimadukunnu having station seniority from 26-04-22. The distance between Govt Taluk Hospital Balussery and Naduvannur Kozhikode is 13 km and hence considered as the same station.

10 PHC Nochad, Kozhikode

Dr. Abhilash R. J, PHC Naduvannur, Kozhikode having station seniority from 19-05-21

11 CHC Narikuni, Kozhikode

While considering the online transfer request submitted by other eligible incumbents to get transfer to Kozhikode district, for

giving an opportunity to all employees to work in their home district Kozhikode, it was compelled to post some incumbents of Kozhikode district to other than their options.In these circumstances,Dr.Nisha J Haridas was posted at District Hospital Vadakara Kozhikode.

Dr.Nisha J Haridas is continuously working at Kozhikode District since 31/07/2012 and presently she is posted at Kozhikode District itself. Most of the options submitted by Dr.Nisha J Haridas are within 15 km from her present station itself. As an appeal was received against her draft list posting (within present station) at PHC Panangad Kozhikode ,it was unable to consider her options within 15 Km. However, Dr. Nisha J Haridas is include in the Queue list of General Transfer 2025 of Assistant Surgeons and she is eligible for posting at vacancy arise at Mental Health Centre, Kuthiravattom, Kozhikode due upcoming promotion of an Assistant Surgeon to Civil Surgeon. The Director of Health Services has recommended to reject the Annexure A8 appeal submitted by Dr Nisha J Haridas.

3) Government have examined the matter in detail. In view of the facts mentioned above the Annexure A8 representation read as 1st paper above submitted by Dr.Nisha.J Haridas for considering the applicant for posting at one of the preferred options is hereby rejected .The order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is complied with as above.
