The candidate should produce the original certificates at the time joining duty that is to prove Educational Qualification, Date of Birth, Identity for verification.

Certificate of Physical Fitness obtained from a Medical Officer in Government service not below the rank of Civil Surgeon/Consultant. The District Medical Officer of Health should verify the above documents and Advice Memo issued to candidate from Kerala Public Service Commission before permitting the candidate to join duty.

The appointment of the candidates are subject to Rule3(c) of the General Rules of the KS&SSR 1958. The appointment is purely provisional and the candidates is eligible for appointment in regular service only if the character and antecedents are found satisfactory on further verification. Her appointment shall be terminated without, further notice, if the appointing authority is not satisfied with her conduct and antecedents on subsequent verification.
