The by-transfer appointment to the post of Junior Health Inspector Gr. II was issued as per the order read as 3rd. But, due to an error in maintaining the ratio prescribed in the government order read as 1st, the order read as 3rd above is hereby cancelled. The above mentioned by-transfer appointments are hereby modified as detailed below.

The following incumbents, who are working in this Department in the feeder category and possess the prescribed Technical Qualification, are found eligible for appointment by transfer to the post of Junior Health Inspector Gr. II in the scale of pay of ₹31,100–66,800. Accordingly, they are provisionally promoted as Junior Health Inspector Gr. II through by transfer under Rule 31(a)(i) of the Kerala State and Subordinate Services Rules (KS&SSR) and allotted to the District Medical Officer (Health) concerned for posting against the existing vacancies reported for by-transfer appointment.

The concerned District Medical Officers (Health) shall issue necessary posting orders to the incumbents. The incumbents shall be relieved from their present duties only after receipt of the posting orders from the District Medical Officers (Health) concerned. The Head of the Institution shall verify the documents in proof of the prescribed qualification and date of birth of the incumbents before permitting them to join duty. If any discrepancy is noticed, the incumbent shall not be permitted to join duty, and the matter shall be reported to this office immediately. The incumbents shall be on probation for a total period of two years on duty within a continuous period of three years from the date of joining duty.

The above instructions and conditions shall be incorporated in the posting orders issued by the District Medical Officer (Health) concerned. The by transfer appointment to the cadre of Junior Health Inspector Gr. II is State-wide and will not come under the purview of inter district transfer norms.
