**ORDER**

Dr. Arun P.V. was appointed on deputation as State Nodal Officer (Projects), National Health Mission (NHM), Kerala as per the Government Order read as 1st paper above and his deputation was extended from time to time and is presently valid up to 17.10.2026 as per the order 2nd cited. Subsequently, as per order read as 3rd paper above he was also entrusted with the additional charge of General Manager, Kerala Medical Services Corporation Limited (KMSCL). Dr. Arun P.V. has since reported administrative difficulty in discharging the duties of both assignments simultaneously and requested to be relieved from NHM, and the State Mission Director, NHM has recommended cancellation of his deputation and
