The candidates shall produce the following documents at the time of joining duty:

- Original documents to prove the date of birth and qualifications.
- A Certificate of physical fitness obtained from a Medical Officer not below the rank of a Civil Surgeon in Government service.
- A Prescribed Community Certificate for candidate whose community is noted.
- The Original Non-Creamy Layer Certificate, which shall be verified before the candidate joins duty.

The appointment of the candidate is subject to Rule 3(c) of the General Rules of the Kerala State Subordinate Services Rules 1956 and the service is liable to be terminated without prior notice. The appointment is purely provisional and the candidate is eligible for appointment in regular service only if the character and antecedents are found satisfactory upon verification.

The Head of Office shall verify the identity of the candidates before allowing them to join duty. For this purpose, a scanned copy of the identification certificate produced by each candidate at the time of the selection test is enclosed herewith. The identification certificate includes a passport-size photograph bearing the candidate's signature. The candidate has also signed the declaration below the photograph on the identification certificate. The Head of Office shall verify the photograph and signature and record the verification on the scanned copy of the identification certificate. If any discrepancy is found, the candidate shall not be allowed to join duty, and the matter shall be reported to this office immediately. After the candidate is allowed to join duty, the scanned copy of the identification certificate, verified and deemed acceptable by the Head of Office, shall be affixed in the candidate's Service Book.

The Service Book shall be opened within one week of the candidate joining duty, and an attested photocopy of the page containing the candidate's name, address, fingerprint, identification mark, qualifications, and the personal memorandum, duly completed and affixed with a passport-size photograph shall be forwarded to this office for PSC service verification. The appointment shall be regularized only after obtaining a Verification Certificate from the Kerala Public Service Commission and a Police Verification Certificate.

The Head of the Institution shall obtain Annexure-1, duly completed and signed by the candidate, before allowing them to join duty and shall forward it to this office for further action. The Head of the Institution shall verify the documents mentioned above and ensure that the particulars provided by the candidate in the statement are correct before admitting them to join duty.

The date on which the candidate joins duty shall be reported to this office. Any

application for correction of the date of birth shall be submitted by the candidate within five years from the date of entry into service, as stipulated in G.O. (Rt) No. 45/91/P&ARD dated 31.12.1991.

If the candidate fails to join duty within the stipulated time, the matter shall be reported to this office, after the expiry of the joining period.

In the event of discharge from service due to a lack of vacancies, the candidates shall re-register their names with the office of the Kerala Public Service Commission (PSC) from which they were advised and seek re-appointment to the post in the department. If they wish to continue as probationers in the post from which they were discharged, they may do so as per Government Circular Memorandum No. 3737/Rule-1/90/P&ARD dated 29.03.1990 and Government Order No. 7/1991/P&ARD dated 15.02.1991.
