**ORDER NO: DHS/13328/2026-EA1. Dated: 08-08-2026**

As per order read as 1st, the appointment orders were issued in the post of Assistant Surgeon/Casualty Medical Officer as per the advice of the Kerala Public Service Commission vide letter read as 2nd. In the order read as 1st, the PSC serial number has not been included. Hence the order is modified incorporating the PSC Serial number of the candidates concerned.

The candidates whose particulars are furnished as per Annexure and who have been advised by the Kerala Public Service Commission as per their letter read as 2nd above for appointment to the post of Assistant Surgeon/Casualty Medical Officer is temporarily appointed in the Health Services Department in the scale of pay of Rs.63700 - 123700, under clause(1) sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10 (b) of those Rules (vide G.O.(P) No.49/74/PD dated-05.03.1974) and posted to the institutions noted against his/her name, subject to the condition that his/her appointment shall be terminated without further notice if the appointing authority is not satisfied with his/her conduct and antecedents on

subsequent verification. They shall be eligible for appointment in regular service in accordance with rules only if their character and antecedents are found satisfactory on subsequent verification. The appointment is also subject to Rule 3 (C) of General Rules of Kerala State and subordinate Service Rules 1958.

The candidates are directed to report for duty before the District Medical Officer of Health concerned within a maximum period of 14 days. Considering the disaster situation prevailing in most of the districts, the candidates are directed to report for duty as early as possible within the prescribed time limit. The candidates who have applied for extension of joining time should join duty on or before the date noted against their names.

The candidates should produce the original certificates ie Educational Qualification, Registration, Non Creamy layer, Fitness etc and ID proof for verification before the District Medical Officer of Health concerned. The District Medical Officer of Health should verify the above documents before permitting the candidates to join duty.

The application for correction of date of birth, if any required should be submitted by the candidates within five years from the date of entry in service. In the case of those candidates who fail to join duty within the stipulated time, their appointment will be cancelled and the vacancy will be reported to the Kerala Public Service Commission as 'Not Joining Duty.'
