The concerned District Medical Officer of Health should issue necessary posting orders to the incumbents. They should be relieved of their duties only after receipt of posting orders from the District Medical Officers (Health) where they are posted. The Head of the institution should verify the documents to prove the qualification and Date of Birth of the incumbent before permitting them to join duty. If any discrepancy is noted, they should not be allowed to join duty and the fact should be reported to this office immediately. The incumbent shall be on probation for a total period of two year on duty with in a continuous period of 3 years from the date of joining duty.

The above instructions and conditions should be noted in the posting order issued from District Medical Office of Health. This by transfer appointment to the cadre of Junior Health Inspector Gr. II is state wise and will not come under the purview of Inter District Transfer norms.

The incumbents are authorized to use the print out of this order published in the official website of Directorate of Health Services for official purpose. The date of relief and joining duty should be reported to this office promptly.
