Dr.Vishnu A PEN.909173 Asst.Surgeon completed his PG Course on 08.09.2021.He submitted request for rejoining duty as per read 2nd above.Since there was no vacancy in the cadre of Assistant Surgeon existed at that time due to the enhancement of retirement age of Doctors from 56 to 60 years as per GO(MS) No.169/2017/ H&FWD Dated 28.11.2017 and anticipatory vacancies reported to PSC,he could not join duty as Assistant Surgeon after completion of PG Course.
