**Order No.DHS/12707/2026-EA2 Dated:30-06-2026**

Dr. Dileep Das S Assistant Surgeon, Primary Health Centre Kottukal, Thiruvananthapuram has been transferred and posted to Taluk Headquarters Hospital, Parassala, Thiruvananthapuram in the draft list of General Transfer 2026 of Assistant Surgeons of Health Services Department.

Aggrieved by this order Dr Dileep Das S Assistant Surgeon has filed an OA No.855/2026 before the Honourable Kerala Administrative Tribunal. In the order read as 2nd paper above, the Hon'ble Kerala Administrative Tribunal directed the 2nd respondent (Director of Health Services) to consider and pass orders on Annexure A8 representation before finalizing General Transfer ordered as per Annexure -A6.

In Annexure A8, the applicant Dr. Dileep Das S Assistant Surgeon stated that he had been continuously working at Primary Health Centre, Harippad for 7 years, i.e., from 01/08/2014 to 04/05/2022. However, as per the General Transfer norms and rules, while working at PHC Harippad, he had availed protection as he belongs to the SC/ST community and is an inter-state married employee. He also stated that he is suffering from certain health issues.

On examining the matter, it was found that he has not produced

any valid Medical Certificate in this regard. Further, it is seen that he has been transferred to THQH Parassala within Thiruvananthapuram District itself. The distance between his present station, i.e., PHC Kottukal, and THQH Parassala is only 16 km. In order to accommodate eligible incumbents from outside the district to Thiruvananthapuram District, it is inevitable to transfer certain incumbents from their present stations.

In these circumstances, it is necessary to transfer Dr. Dileep Das.S, Assistant Surgeon from PHC Kottukal to THQH Parassala so as to accommodate Dr. Vijin S S Assistant Surgeon from MOBILE MEDICAL UNIT II AGALI, who has opted for the said station.

Considering the above facts, the Annexure A8, representation submitted by Dr. Dileep Das.S, Assistant Surgeon is hereby rejected. Thus, the order of the Hon'ble KAT read as 2nd above is complied with accordingly.
