As per the order read as 4th paper above, Dr. Aiswarya P., Casualty Medical Officer, Taluk Hospital, Kuttippuram, Malappuram, was transferred and posted to Taluk Hospital, Feroke, Kozhikode, subject to the condition that the placement would be reviewed during the General Transfer 2026, if required.

2.Accordingly, upon reviewing the General Transfer 2026 of Assistant Surgeons in the Health Services Department, Dr. Aiswarya P., Casualty Medical Officer, Taluk Hospital, Feroke, Kozhikode, was transferred and posted to Taluk Headquarters Hospital, Nadapuram, Kozhikode, against an existing open vacancy.

3.Aggrieved by the said transfer order, Dr. Aiswarya P., Assistant Surgeon, filed O.A. No. 855/2026 before the Hon'ble Kerala Administrative Tribunal. Vide order read as 2nd paper above, the Hon'ble Tribunal directed the 2nd Respondent (Director of Health Services) to consider and pass appropriate orders on the appeal (Annexure A8) submitted by the applicant, duly taking into account her medical condition, within a period of one month from the date of receipt of a copy of the order.

4.In her representation (Annexure A8), the applicant requested accommodation in any one of the three specific vacancies pointed out by her. However, vide order dated 09.07.2026, the aforementioned

vacancies were filled through the general transfer order.

5.In light of the above facts, the representation (Annexure A8) submitted by Dr. Aiswarya P., Assistant Surgeon, is hereby rejected. Her request for transfer shall be considered against upcoming vacancies as per procedure.

6.The order of the Hon'ble Kerala Administrative Tribunal read as 2nd paper above is complied with accordingly.
