The Candidate appointed will come under the new pension scheme.

The Candidate should produce the following documents at the time of joining duty.

- Original documents to prove the date of birth and education

qualification etc.

- Certificate of Physical Fitness obtained from Medical Officer in Government Service not below the rank of Civil Surgeon. The candidate should affix recent passport size photograph duly attested by the issuing officer.
- Those who are in reservation quota shall produce the original Community Certificate and Non - Creamy Layer Certificate.
- Conduct Certificate.
- Original One Time Verification Certificate.

The appointment order in this proceedings is purely temporary and the candidate is eligible for appointment in regular service only if his character and antecedents are found satisfactory on subsequent verification.

The appointment shall be regularised only after obtaining a verification certificate from the Kerala Public Service Commission and the Police Verification Certificate.

In the event of discharge from service for want of vacancies, the candidate may either register his name in the office of the Public Service Commission from where he was advised and get himself re-appointed on further advice by the Public Service Commission or he may wait for his turn for re-appointment to the post in the department in case he desire to continue as probationer in the posts from which he was discharged vide Government Circular Memorandum No.3737 Rule 1/90 P&ARD dated, 29/03/1990 and Government Order No. 07/1991/P&ARD, Dated: 15/02/1991. The appointment is also subject to Rule 3(c) 7 General Rules of Kerala State and Subordinates Service Rule 1958.

Application for correction of date of birth if any needed should be made by the candidate within five years from the date of entry in service as laid down in GO(Rt.) No. 45/91/P&ARD, Dated: 31/12/1991.
